The proposed course Self Care Pharmacotherapeutics I is the first in a sequence of course that includes the first course listed PHA 742 Patient Assessment and Self Care. These two courses will now be a course sequence focused on over-the-counter medications and dietary supplements. A separate minor course modification is being submitted to change the name of PHA 742 to Self Care Pharmacotherapeutics II to reflect this course sequence. HLTH 200 includes dietary supplements as a component of the course, but it does not include over-thecounter medications. The proposed course will also have a focus on pharmacist evaluation of patients for appropriateness of self care therapies and patient education on use of over-thecounter products and dietary supplements.

The Self Care Pharmacotherapeutics course sequence will focus on over-the-counter medications and dietary supplements. This content is currently covered in Pharmacy Practice I (PHA 368) and Patient Assessment and Self Care (PHA 742). The self care content from PHA 368 will be moved into the new Self Care Pharmacotherapeutics I course, and Patient Assessment and Self Care will be renamed Self Care Pharmacotherapeutics II. This will create better continuity of content between the courses and will allow for increased focus on nonprescription therapies.
