The field experiences in ECE 296 of 30 hours per semester was found to not be enough initial time in the two early childhood settings -15 hours with children ranging in age from 1 to 5 years and 15 hours

with children ranging in age from 6 years to 8 years. Moving to a 1-credit lab for each course (ECE 320 & ECE 360) provided 45 per semester for each age group.
