7. Explanation of the Change:

The proposed changes clean up the list of classes for the HR minor:

- Replaced the more general BLAW 350 Legal Environment of Business, with a more specific labor law class BLAW/ECON 467 Labor Law and Economics.
- Moved PSYC 331 Industrial and Organizational Psychology and SOC 353 Sociology of Work from required classes to elective classes.
- Added MGMT 464 Organization Behavior to required courses.
- Cleaned up list of elective classes.
- Added GPA requirement that is on all Ness School minors.
