Provide explanation of differences between proposed course and existing system catalog courses below:

The proposed course, ENGL 471-571, differs from the existing courses in that its focus is on the theory and practice of academic editing and publishing, with an emphasis on academic journals but can also include other academic publications such as scholarly books, book reviews, and white papers, to name a few. Other courses in the system that focus on professional writing (including editing) do so by way of grant writing and/or technical/professional writing, but they typically do not include coverage of academic editing and publishing. Because academic editing and publishing skills are transferable across multiple modes of writing, this course will prepare students for professional careers that require editing and publishing expertise. Undergraduate students who successfully complete the class are eligible to be employees for the Victorian Periodicals Review academic journal, which is housed in the SDSU School of English and Interdisciplinary Studies, until they graduate. Graduate students can add the course to their profile as they seek academic jobs upon graduation.

1. Provide specific reasons for the proposal of this course and explain how the changes enhance the curriculum.

This course was previously offered as ENGL 492-592 Topics: Academic Editing and Publishing. It fulfills a specific need for students who intend to pursue careers that require diverse sets of writing skills. Further, this course fulfills a noted gap in the curriculum in that it is a writing-intensive course that prepares students in the art of academic editing and publishing. Undergraduate students who successfully complete the class are eligible to be employees for the Victorian Periodicals Review academic journal, which is housed in the SDSU School of English and Interdisciplinary Studies, until they graduate. Graduate students can add the course to their profile as they seek academic jobs upon graduation. It will count as an elective in the English and Professional Writing minors as well as an elective for both the BA and MA in English, thus enhancing multiple curriculums.

The graduate level section will involve a higher level of academic rigor for the graduate students. This includes expectations for leadership in class discussion and decorum (including attendance),

mentorship of undergraduate students through leading discussions on academic editing and publishing theories and practices, both historical and contemporary, and completing additional readings and assignments such as a formal presentation of more complex/upper-level theories to the class. In addition, they will produce writing assignments that have higher expectations for incorporated research and development of complex ideas. This involves the requirement of more sources for each writing assignment, the ability to discuss these sources clearly in writing, and the ability to discuss their research with their fellow students. Finally, they will produce culminating projects (textual history essay and edited essay with self-reflection and editing notes) closer in length to a seminar-length project (18-20 pages), and they will share the results of their work with the class. The final exam is the same for all students.
