Definition: A program that focuses on the systematic study of human social institutions and social relationships. Includes instruction in social theory, sociological research methods, social organization and structure, social stratification and hierarchies, dynamics of social change, family structures, social deviance and control, and applications to the study of specific social groups, social institutions, and social problems.

Proposed CIP Code: 44.0201; Title: Community Organization and Advocacy. Definition: A program that focuses on the theories, principles, and practice of organizing and providing services to communities. May prepare individuals to apply such knowledge and skills in community service positions.

8. Explanation of the Change:

The School of Psychology, Sociology and Rural Studies requests to update the program's CIP code. The online certificate in Community Development focuses on refining a student's leadership ability and hands-on skills needed to help communities and regions build their own capacity for an inclusive, sustainable future. The code would change to 44.0201 (Community Organization and Advocacy). This change is requested to update the CIP code to accurately reflect the nature of the program.
