MCOM 221 Audio Production and MUS 204 Introduction to Digital Sound Design appear to be focused on sound and recording for film, video, and other electronic media (video games, etc.). While many of the fundamental elements of audio production are common across disciplines, the proposed course will focus on sound and audio production as it relates to the artistic and practical elements of theatrical design, as well as recording and sound editing musicians and music educators. MUS/THEA 447 will be used in the curriculum to help fulfill NAST (National Association of Schools of Theatre) and NASM (National Association of Schools of Music) accreditation requirements.

1. Provide specific reasons for the proposal of this course and explain how the changes enhance the curriculum.

While audio recording, playback, and technology are briefly discussed in a few classes in both MUS and THEA, this will be the first class at SDSU focusing specifically on sound production. It will allow students to explore topics in sound design and technology in a much greater detail than has been available previously.

For the B.A. and B.S. in Theatre:

NAST (National Association of Schools of Theatre) requires that "Students must acquire a working knowledge of technologies and equipment applicable to their area(s) of specialization," within its list of the Common Body of Knowledge and Skills for all professional baccalaureate degrees in theatre (NAST Handbook VIII.B.4). Additionally, NAST lists six areas within Production that also fall within the Common Body of Knowledge and Skills (VII.B.4.a-f) that are required of students within a theatre program. This course will help to fulfill those requirements for students seeking this degree.

For the B.A. in Music - Music Studies Specialization and the Bachelor of Music Education: The NASM handbook specifies "Knowledge of ... technologies...) in its list of competencies for various specializations within the undergraduate music degree. This course would fulfill that requirement.

For the B.A. in Music - Music Entrepreneurship Specialization:

In the Common Body of Knowledge and Skills in Music Industry and Business (Appendix 1.E.D.2.a.(6)) the NASM handbook lists "Functional knowledge of computer and technological applications in the music industry." This course would help to fulfill that requirement for those seeking this degree.
