NURS 320 and NURS 334 are both nursing theory courses, however, each focus on unique concepts and exemplars which are different from the proposed course. NURS 320 focuses on the development of the generalist role as provider of care, designer, coordinator, manager of care, and member of the profession. Professionalism is integrated as core in the development and application of evidence-based competence in nursing technical skills, knowledge, attitudes, and patient care technologies. NURS 334 focuses on concepts and exemplars related to pediatric and adult health. The proposed course will focus on disease prevention, health promotion, and management of care across the lifespan. Additionally, NURS 334 is part of the current BSN curriculum and will remain in place until currently enrolled students finish and then this course will be terminated.
