NURS 372 covers concepts such as caring, ethics, healthcare economics, health care quality, health care systems, health law and policy, among others. The proposed course will cover concepts such as caring, collaboration, communication, evidence-based practice, hospice and palliative care, population health, quality improvement, self-care, among others. Additionally, NURS 372 is part of the current BSN curriculum and will remain in place until currently enrolled students finish and then this course will be terminated.
