NURS 330 and NURS 344 are both nursing theory courses, however, each focus on unique concepts and exemplars which are different from the proposed course. NURS 330 emphasizes concepts associated with health and wellness and implementation of primary and secondary nursing interventions. NURS 344 focuses on health and illness concepts with exemplars specific to gerontology and mental health. The proposed course will focus on disease prevention, health promotion, and management of care across the lifespan, including caring for specialty populations. Additionally, NURS 344 is part of the current BSN curriculum and will remain in place until currently enrolled students finish and then this course will be terminated.
