Provide explanation of differences between proposed course and existing system catalog courses below:

The existing courses are both clinical courses for undergraduate nursing students intended for clinical experiences in the off-campus environment, however, the concepts and outcomes differ compared to the proposed course. Each nursing clinical course has unique components that necessitate unique courses. NURS 441 focuses on end-of-life care, chronic disease, and the interprofessional team while the proposed course focuses on both acute/chronic conditions across the lifespan. NURS 435 focuses on obstetrics and adult med-surg while the proposed course will focus on advanced med-surg and population care. Additionally, NURS 435 is a part of the current BSN curriculum and will remain in place until currently enrolled students finish and then this course will be terminated.
