Provide explanation of differences between proposed course and existing system catalog courses below:

NURS 352 is intended for RN to BSN students who are already practicing nurses and therefore, would not apply to nursing students. NURS 322 is the only pharmacology course that nursing students take, while the proposed course would be the second of two pharmacology courses taken by the nursing student. Faculty have determined the need for an introductory pharmacology course taken earlier in the nursing program followed by a second pharmacology course taken later in the plan of study to ensure reinforcement before practicum and nursing practice. Additionally, NURS 322 is part of the current BSN curriculum and will remain in place until currently enrolled students finish and then this course will be terminated.
